## **PETITION FOR THE EXPULSION OF MR. KENNEDY OHENE AGYAPONG FOR HIS ANTI-PARTY BEHAVIOUR**

We the members of the above group write to formally request for the outright expulsion of the former Assin Central MP and former flagbearer aspirant, Mr. Kennedy Ohene Agyapong, from the New Patriotic Party for the highly unacceptable remarks he has recently made about our party and its past governments.

We express our disappointment over his public outbursts as they are highly unfortunate especially when he as a person has been a huge beneficiary of the very party that he seeks to humiliate, undermine and destroy.

He is on record for threatening to disclose sensitive information about the party if provoked. These are comments he made during an interview on Net 2 TV on Thursday, June 18, 2026, and as anti-party behaviour as his conduct is, it violates Article 3 of the NPP constitution which requires members to “be truthful and loyal to the party” and to “protect and promote the good name of the party”.

One would have thought that, as a senior member of the party, he would have been guided and mindful of his public commentary about both the party and its successive governments, but clearly, he is on a mission to create chaos and undermine the unity and integrity of the party, hence the deliberate attempt to drag the image of the party to the mud.

Mr. Agyapong knows very well that our party's electoral fortunes in the next General Elections remain closely tied to our performance and achievements in the previous NPP administrations, yet he is deliberately undermining our party's huge contributions to the country's development with these unfortunate remarks.

Indeed, no true or well-meaning member of our great party will dare disregard the legacies and records of both the Kufuor and Akufo-Addo administrations with respect to the development of the country.

Mr. Kennedy Agyapong's remarks are very much regrettable to say the least, and we therefore call on the leadership of the party to expel him outrightly as it is obvious he is on a mission to undermine and destroy.

While we call for his outright expulsion from the party, we will want to remind him that, even Kwame Nkrumah, upon all the state machinery at his disposal, couldn't break the UP tradition, even after detaining the likes of Dr. JB Danquah, Baffour Akoto, etc and forcing others to go on exile. Today, the UP tradition still stands and lives on in the NPP while his CPP is a pale shadow of its former self.

We can also talk of the unsuccessful frantic efforts by the Acheampong regime to obliterate the same UP tradition. Eventually, his regime was rather truncated, and the UP tradition is still alive. Then the unsuccessful attempts by former President Rawlings to frustrate the reorganisation and regrouping attempt of the UP tradition into the NPP by going after pro-UP businesses, businessmen and financiers. Ultimately, the NPP was successful in regaining power while Rawlings and his wife were chased out of their own party.

Our point is simple. No one has attempted in undermining or fighting the UP tradition and has succeeded.

But as we conclude, we humbly and respectfully call on the leadership of the Party to act on the expulsion processes of Mr. Kennedy Agyapong as quickly as possible without holding back as this is the best decision we can take at this point in time.

Indeed, history tells us that, greater and more formidable figures of our party or the UP tradition left or were suspended, yet their departure couldn't stop us from winning power.

Joe Appiah relying on his popularity and great oratory skills thought he could leave, form a party and win power at the expense of our tradition but he failed.

We also remember how Alhaji Inusah Fuseni then close confidant and Campaign Manager of then Candidate John Agyekum Kufuor defected to the NDC, yet the NPP and Mr. Kufuor went on to win the 2000 General Elections.

Another instance can also be cited in the case of Mr. Paul Afoko, Mr. Sammy Crabbe, Mr. Kwabena Agyepong and numerous other party officers who were suspended across the country, yet the party still soldiered on to win the 2016 General Election with Nana Addo Dankwa Akufo-Addo. As we speak, Mr. Afoko and Mr. Crabbe are back to contest for the National Chairmanship position. Mr. Kwabena Agyepong, on the other hand, has since contested in about two different presidential elections in the party. This is all because the party didn't collapse and is still attractive.

Last but not least, the 'darling boy' of Ashanti, Mr. Alan Kyerematen recently left the party with some of our members to form his movement, yet most of the very people he left with are back to join the party, proving how strong the party still is.

Our point again is, all the aforementioned persons contributed hugely to either the formation of the tradition or its securing of power, unlike Mr. Ken Agyapong who was rather made by the party. He has enjoyed hugely from the party in terms of big and juicy contracts and there are records to prove this. So, if the party or the tradition survived the expulsion, defection or breakaway of those influential figures and went on to win power, expelling Mr. Kennedy Agyapong from the party will not derail our chances in winning the 2028 General Election.

We therefore call on the party to expel him because no one would and should be allowed to stand in the way of the NPP and Dr. Mahamudu Bawumia in our quest to win the next General Elections.
